11/17/22	Ratio Measures with single Initial Population and Measure Observations will not calculate properly
11/17/22	Ratio Measures with two Initial Populations will not calculate properly

December Release

The following issues are being addressed as part of a December Release.

Date Added	Issue Description
11/17/22	Discard Changes Button is not clearing changes in the JSON editor for brand new test cases
11/17/22	Users that do not own a CQL Library will see Draft and Version options in the Actions Drop down. The user can click the button but the tool will prevent the action from executing because they are not the owner.
11/17/22	Switching the number of results returned for a page after searching will clear the measure search results. Work around: Switch the number of results prior to executing a measure search
11/17/22	Users that have a measure search that returns more than one page of paginated measure results will not be able to access more than the first page of results Work around: Refine Search criteria, or select more results per page to be returned
11/17/22	When viewing the measure group page in a measure for which the user does not have edit privileges, some fields are not displaying and some fields display as if they can be edited. Non-owners cannot actually save any of the data.
11/17/22	Occasionally the Test Case JSON editor does not load fully but becomes editable. If the user edits the JSON during this time the save button will never become available for the user to save. Work around: reload the page and complete changes again
11/17/22	When on the Edit measure page the back button does not take users back to the Measure List page Work around: Click the MADiE logo to return to the Measure List Page

Date Added	Issue Description
11/17/22	<p>After correcting Test Case Errors the errors do not always clear from the validation Errors list.</p> <p>Work around: Save Changes, navigate to the test case list page, return back to edit the test case.</p>
11/17/22	<p>CQL validation issues occur when a definition name is resolvable to a quoted identifier but the definition name is not in quotations. Users may not receive CQL validation errors, however the Population Criteria section won't render and a blank screen will display.</p> <p>Work around: Quotes should be added to all define statement names, even when it is resolvable to a quoted identifier.</p>
11/30/22	<p>Measures that have been transferred from MAT to MADiE are currently not displaying the correct version number on the Measure List page. This is a display issue only.</p>
11/30/22	<p>Measures that have been transferred from MAT to MADiE should retain the version number for the primary CQL Library. Currently, when a user edits the measure on the CQL Library Editor page, the measures' primary CQL library is changed to version 0.0.000. Currently users cannot update this version number in the CQL Editor.</p>
12/2/2022	<p>If a user transfers measures from MAT to MADiE, MADiE is only recognizing the measure types that are present in the HL7 measure type list. These types including, Outcome, Patient Reported Outcome, Process and Structure.</p> <p>If a user tries to transfer a measure that is not one of these types, the transfer action is not completing.</p> <p>Work around: Users can change the measure type to one of the four accepted measure types in MAT prior to transferring it to MADiE.</p>
